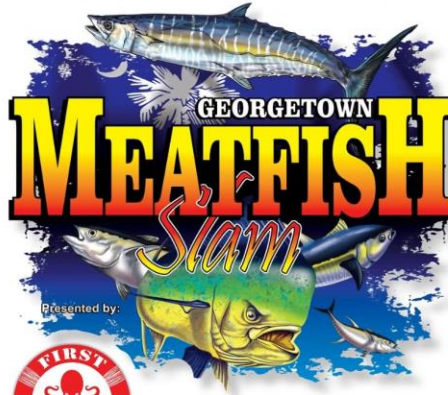

All persons connected directly or indirectly with the operation of the Georgetown Meatfish Slam, whether individual or corporation, shall be exempt from any liability for libel, slander, loss, damage, negligence, harm, injury or death suffered by any participants, entrants, their companions, boat captains, mates, crew members, vessels, and equipment which may occur during the tournament. By registering in the tournament, each team member consents to the use, without payment or restriction, any photograph, video, TV or sound in which he or she appears for any purpose whatsoever. This release shall also be binding on my heirs, executors, administrators or assigns. Any prize money must be reported to the IRS. By signing this entry form and paying the entry fee, my team and I acknowledge that we have read the rules and the release and are bound by the same.

# SCHEDULE OF EVENTS

April 11, 2025

**6:00 pm** Captain's meeting at First Mates Location, 189 Industrial Drive Lane

**6:30 pm: Entries and Payments must be submitted at this time.**

April 12, 2025

7:00 am: First day of fishing begins.

3:00 pm: Lines Out!

6:00 pm: Weigh scales close (Must be in line to weigh at fish cleaning area to weigh).

April 19, 2025

7:00 am: Last day of fishing begins.

3:00 pm: Lines Out!

6:00 pm: Weigh scales close (Must be in line to weigh at fish cleaning area to weigh).

7:00 pm: Awards Dinner and Beverages provided on the dock.

## RULES

1. Boats may leave from Charleston, SC, Georgetown, SC, or Murrells Inlet, SC, or Little River, SC.
2. Official tournament time will be continuous GPS time.
3. Lines in at 7:00 am April 12<sup>h</sup>- April 19<sup>th</sup>, 2025. Boats are eligible to fish 2 days. Participants must let the tournament committee know which day(s) they will be fishing, the day prior to fishing via phone call to GLM or text. LINES must be out at 3 pm the same day. All boats must be in to weigh fish at Georgetown Landing Marina by 6 pm. NO fish may be brought to scales by vehicle; it must be weighed from the boat in which it was caught unless advised differently by the tournament committee to account for mechanical or safety issues. No mutilated fish will be weighed.
4. Small craft at 6 am NOAA Inshore Report declares an ineligible fishing day.
5. All fish must be caught from conventional rod and reel. J- Hooks or Circle hooks are allowed, as well as lures and artificial baits. No electric reels, bandit reels or "Green sticking."
6. In the event of a tie on weight, the first fish weighed will take the highest place.
7. For the tuna category, only Blackfin tuna and yellowfin tuna count.
8. Only one fish from each species will count towards each category. Each boat may only claim 1 place in each category. Days will combine, so heaviest fish from each category will be selected out of both (2) days.
9. A member from the boat must be present to weigh-in each fish.
10. The aggregate is the combined total of your heaviest tuna, heaviest dolphin, & heaviest wahoo caught during the tournament (all three species required). If no boat catches all 3 species then the HEAVIER of two categories will win. **(3 lighter fish will beat 2 heavier fish).**
11. Tuna, Dolphin, and Wahoo categories will pay one place.
12. All tournament entry fees are due by **6:30 pm** on Friday April 11 at Georgetown Landing Marina.

## PAYOUT

*Grand Prize paid to Largest Aggregate*

The aggregate is the combined total of your heaviest tuna, heaviest dolphin & heaviest wahoo caught during the tournament (all three species required). If no boat catches all 3 species then the heavier of two categories will win. **(3 lighter fish will beat 2 heavier fish).**

Tuna, Dolphin, and Wahoo categories will pay out one place each.

Payout on each Category will be determined after captains meeting.
